Covenant of Care

We are taking this opportunity to reach out to our congregation to communicate to you our promise to deliver safety and civility as we move forward through the ebb and flow of changes in reaction to global restrictions over the past year. We are closely monitoring government policy changes and guidelines from the [Centers for Disease Control \(CDC\)](#) as well as federal, state and local government mandates and any other public health advancements, and will continue to make changes as necessary or appropriate to our Covenant of Care. Our motto is "Your Family. Your Home.", and we take this message to heart. We hope that you will find comfort in the increase in safety and sanitization measures that we have employed with each of you in mind. Please read over the following updates and guidelines to make Temple Sinai a safer community.

Entering Temple Sinai

Vaccination records are required to come to Temple for all events, ages 12+. For those unable to provide a vaccination record, you may submit a COVID-19 test taken within 3 days prior to the event, submitted 24 hours in advance. Vaccination records can be sent to Lori Dougherty at controller@templestinailv.org to be kept on file. You only need to submit vaccination records once.

Face masks that cover the nose and mouth and chin are to be worn. Face shields are not a suitable replacement for face masks. Face masks are available immediately inside the front door for those who are in need. Touch-free hand sanitizer dispenser stations are positioned in high-traffic locations.

Sanctuary & Shabbat Services

Congregants are encouraged to sing safely and not to project their voices out of consideration for others.

During the Oneg individually wrapped Kiddush Kits and bottled water will be provided.

Restrooms and Fountains

Restrooms are equipped with touchless toilets, sinks, soap dispensers, and paper towel dispensers. Restroom doors will be propped open. Drinking fountains are currently not in service.

Cleaning and Sanitization

Temple Sinai is grateful for our facilities team, who clean and prepare our beautiful synagogue for small groups and Shabbat services. They are diligent in following protocol and conscientious of maintaining cleanliness throughout the building. Please know that we sanitize our Sanctuary before and after services, as with any of our rooms available for use.

We will continue to revise this plan accordingly as restrictions and social-distancing mandates improve.
